

TRAIL ZONE's **CHOOSE YOUR RIDE** SUBSCRIPTION PROMOTION: TERMS & CONDITIONS OF ENTRY

1. Information on how to enter and prizes form part of the Terms and Conditions of Entry. Participating in this promotion is deemed acceptance of these Conditions of Entry.
